My consent also explicitly refers to the fact that the requested personal data may be transmitted from Freiburg, Germany to countries outside the European Union.

I am aware that the transfer of personal data to countries outside the European Union is subject to risk, unless there is an adequacy decision by the EU Commission pursuant to Art. 45 GDPR and suitable guarantees within the meaning of Art. 46 GDPR. In these cases, there is no level of data protection comparable to the European Union. The University of Freiburg cannot ensure that data protection regulations and data subjects' rights are guaranteed in a manner as they would be within the European Union. In particular, according to the regulations and political conditions applicable in the third country, security authorities, public prosecutors, narcotics authorities, intelligence services, etc. could gain access to my data without judicial or other independent control. This could result in risks with regard to confidentiality (e. g. disclosure to unauthorized parties or people), integrity (e. g. unauthorized modification) or availability (e. g. unauthorized deletion). I could suffer damage, for example due to identity theft, damage to my reputation, political persecution, necessary expenses or financial loss, loss of control over my own data or discrimination. The University of Freiburg cannot conclusively verify the legal data protection status at the location of the requesting institution.

Voluntariness of the consent

This consent is freely given. The requested confirmation will not be issued to the requesting institution without consent. Refusal to give consent has no further consequences at the University of Freiburg.

Withdrawal
